This guarantee is for the full amount of rent, damages and/or legal fees. This can include rent through the end of the lease if Tenant fails to perform all conditions of the lease. All guarantors of the property have the same responsibility for the full payment, not a pro-rated share. Any excess payments will be refunded. If a roommate does not have a guarantor it is the responsibility of the Tenant(s) to notify their guarantors, not ChicoForRent and/or their assigns. In addition, in the event an action is brought to require performance of the above stated conditions, the prevailing party may be entitled to recover reasonable attorney's fees and court costs. Any action, which may be required, will be held in the court of jurisdiction in the Chico, CA area.

This form is for guarantee of lease payment only. It does not make you a party to the lease agreement. This means that we will only respond to inquiries and demands directly from Tenants.

I have read the above terms and conditions and hereby agree to be bound by them. Furthermore, I agree to allow ChicoForRent and/or their assigns to complete credit check and income verification. I also agree that this guarantee can only be canceled with the written concurrence of ChicoForRent and/or their assigns. As required by law, you are hereby notified that a negative entry on your credit report may be submitted to a credit-reporting agency if you fail to fulfill the terms of this obligation.

By signing the lease agreement and this letter you are aware of our rent payment policy. We require that your rent be paid by Electronic Funds Transfer (EFT) each month or the entire lease period (one year) be paid in advance. This means that your bank account will be debited on the 3rd of each month for the full amount of the house rent. If there is not sufficient funds in your account at that time you will be charged a \$35.00 fee to cover our costs plus any late charges due.

Please make sure you have deposited all of your roommate's checks into your account with enough time for them to clear to avoid a NSF charge.

It is up to you and your roommates to decide which bank account to register for payment of rent but only one account may be used. If you require a change of accounts at any time a change fee of \$30.00 will be charged to cover administration costs. **All changes require a minimum of 20 days advance notice.**

Your first month's rent, any partial second month's rent to get to the 1st of the month, plus your security deposit must be paid by check or money order in full when signing the lease.
